My key chain and an umbrella were stolen from me by your officers (yes, the same ones that are supposed to be lawful as part of their very job!). As Glenn Greenwald has said about you, I expect the kind of defining stupidity of your "following orders" @ssh013ss. I did notice them as part of their usual check in/out procedures and I did notice a delay as my property was being scanned, but at this moment I was reading, thinking about some other matters, about how to talk to my mom about a number of issues without making her worry too much and missing my dad. Yet, when I mentally replayed that moment I realized "you got me". You were even making fun of me, making your snitching @ssh013ss tell me as I walked under a drizzle to my mother's place: "don't you need an umbrella?" As usual, I did notice them also chaperoning me as they do each time I fly.
